## Commencement of Membership

Once the application is approved, the Society will include the email addresses into the distribution list and will invoice your company. The membership will commence on the preceding 1<sup>st</sup> of April.

### **Note on Membership fees**

The membership fee for each member company is 200S\$ flat.

Membership fees are invoiced separately after approval of this membership application. The annual membership is automatically renewed each year, invoiced and due payable on the 1<sup>st</sup> of April. Membership rights and privileges are contingent upon receipt of payment.

The annual membership covers the Society's financial year from 1<sup>st</sup> of April until 31<sup>st</sup> of March. Membership fees are to be paid for the complete financial year independent of the actual commencement date of the membership. The membership period (April to March) is fixed and can not be adjusted to any other periods.

Payments are to be made by crossed cheque in favour of: Fieldbus Foundation Marketing Society Singapore. If payments are not received within 30 days from the due date stated on the respective invoice, membership privileges will be denied until full settlement of account is made. In addition, late payment fee of 30 S\$ per reminder is applicable. If the payment is overdue by 3 months or more, the membership will be terminated and the Committee may take legal action against him, provided that they are satisfied that he has received due notice of his debts.
